3. Supervising the Board of Management (BOM) by the Board of Directors (BOD)

- The BOD has carried out their oversight and direction over the BOM on SAIGONBANK's business in line with the orientation and strategic targets. Solutions were proactively and consistently implemented, to assure a good alignment with the expected roadmap and proposed objectives. Besides navigating and instructing the business mission implementation from the beginning of 2025, the BOD has approved specified plans enabling the consistent implementation carried out by the BOM in the entire system.
 - Directing SAIGONBANK to strictly comply with the policies of the



Government and the State Bank of Vietnam (SBV) in banking operation:

- + Properly implementing regulations on limits and adequacy ratios during the course of business; continuing to maintain managing solutions for stable banking activities, to meet the liquidity requirements.
- + Carrying out tight management on lending quality, pushing credit growth in compliance with the common targets assigned by the Government and SBV; Setting plans and synchronously carrying out solutions to support enterprises and the community to recover and develop production and business; proactively balancing capital sources, navigating the credit granting activities to serve priority areas, manufacturing and business sectors, and economic growth drivers on the basis of compliance with legal regulations, with SBV, ensuring business safety and efficiency.
- + Directing to encourage the expansion of green credit and low-carbon production and consumption sectors in order to support environmental preservation. With eight projects, the outstanding green credit balance as at 30/06/2025 was VND 178,72 billion; Improving resource and energy efficiency to help the banking sector implement its green growth action plan, progressively enhancing SAIGONBANK's reputation as a green bank, and integrating ESG into operations.
- + Directing to implement SAIGONBANK's information technology-related solutions, ensuring a close connection with its business plan, optimizing resources, and efficiently managing IT risks.
- During BOD meetings, the BOM reported on SAIGONBANK's operations; the execution of GMS and BOD resolutions/decisions; specific topics on request; the barriers and hindrances encountered during the resolution executing process. As a result of the business assessment, operation evaluation, and market scenario analysis, the BOD timely issued certain resolutions on direction and instruction.
- Directing, supervising the implementation of the GMS resolutions and the BOD decisions:
- + Supervising and promoting the business performance in accordance with the objectives set by the GMS and the 2025 business proposals;
- + Finalizing the development of a proposed remedial plan in the event that early intervention is required for SAIGONBANK;
 - + Appointing, reappointing, dismissing personnel;
- + Directing, supervising the application of policies, procedures, and internal management rules for individual operations for timely revision, supplementation or issuance, guaranteeing compliance with regulations and striving to adopt advanced international practices and standards;
- Encouraging and directing the BOM to produce and release the Annual Reports and Quarterly/Annual Financial Reports by the deadline.

4. Activities of Committees under the BOD (if any)

SAIGONBANK has established committees under the BOD as prescribed by the SBV:

4.1. Board Nomination Committee (BNC)

The BNC was improved to suit SAIGONBANK's actual operation from time

to time, strategically advised the BOD and fulfilled the instructions regarding SAIGONBANK personnel affairs and qualification, achieving the below results:

- Resolving personnel organization redundancies and enhancing SAIGONBANK's human resource qualifications;
- Selecting, arranging and improving personnel for the positions within the BOD's authority; Consulting the BOD on handling personnel issues that have arisen during the process of electing, appointing, dismissing, removing officials in accordance with statutes, regulations; Taking strict action against violations of regulations and codes of conduct...;
- Enhancing training, forming a potential pool of human resource and creating a long-term recruitment strategy that is appropriate for the current circumstances and development trends;
- Strategically advising the BOD on defining regime on salary, remuneration, bonus for employees at SAIGONBANK; assisting the BOD in supervising the execution of regime, policy on human resources;
- Overseeing SAIGONBANK's compliance with the provisions of the law on utilizing human resources.

4.2. Board Risk Committee (BRC)

The BRC was periodically modified to better suit SAIGONBANK's actual operations. By strictly adhering to SAIGONBANK's business plan for the first half of 2025 and operations, the BRC performed the following functions and tasks:

- Reviewing and assessing the consistency and efficacy of SAIGONBANK's risk management procedures and policies in order to make suggestions and proposals to the BOD regarding the need for modifications to present procedures, policies, and strategies; Strategically advising the BOD on issuing regulations and policies of risk management: issuing regulations on internal evaluating the capital sufficiency, approving reports on internal evaluating SAIGONBANK's 2024 sufficient capital...
- Advising the BOD to monitor compliance with the SBV's regulations on banking safety indicators; SAIGONBANK's regulations on risk appetite, limits, and types of risks in banking activities related to credit risk, liquidity risk, interest rate risk, exchange rate risk, operational risk, and so on.
- -Regularly observing the execution of SAIGONBANK's risk management policies; timely producing risk warnings and respective recommendations for SAIGONBANK's regulations, policies on products and services.

3. BOS's oversight over the BOD, the BOM and Shareholders

- The BOS has carried out their work of supervision over SAIGONBANK's governance and executive operations in respect of its compliance with the law and internal rules, charter, resolutions, decisions of the GMS, the BOD.
- The internal audit has been organized and implemented to fulfill assigned tasks and execute the approved internal audit plan. Through internal audit activities, the BOS has not only monitored the compliance with legal and internal regulations of SAIGONBANK, but also evaluated the efficiency of critical business activities as well as figured out the possibility that SAIGONBANK's safe operation might be exposed to certain potential risks. Accordingly, recommendations and proposals have been made to escalate existing issues and limitations to the relevant authorities for due resolution.
 - Appraising the Financial Statements of 2024.
- Shareholders owning 1% or above of the charter capital, together with related members of the BOD, of the BOS, of the General Director of SAIGONBANK and shareholders owning 1% or above of the charter capital have been listed; this list has been maintained and regularly updated upon changes. For the first 6 months of 2025, there was a change in shareholders owning 1% or above of the charter capital: Phat Dai Cat Joint Stock Company rose the ownership from 4,945% to 9,889% of SAIGONBANK's charter capital.
- Other inspection and supervisory activities have been conducted as prescribed by the law.

4. Coordination between the BOS and the BOD, the BOM and other managers:

Throughout their work, the BOS has received necessary information and documents regarding executive management, operation, and business activities of SAIGONBANK for their inspection and supervision.
