### 3. Supervising the Board of Management (BOM) by the Board of Directors (BOD):

- The BOD carried out their oversight and direction over the BOM on SAIGONBANK's business in line with the orientation and strategic targets; the solutions have been proactively and consistently performed, to assure a good alignment with the expected roadmap and certain aims. In addition to guiding and directing the implementation of business tasks, from the beginning of 2025, the BOD approved policies, plans, and strategies, enabling affiliated units to develop various operational aspects.

- The BOD supervised, directed the General Director to manage SAIGONBANK to strictly comply with the policies of the Government and the State Bank of Vietnam (SBV) in banking operation; properly implemented regulations on limits and adequacy ratios during the course of business; maintained managing solutions for stable banking activities.

- Directing to execute the Restructuring Plan for the period 2021-2025, under the direction of the Prime Minister and the SBV; supervising the implementation of the Restructuring Plan; ensuring SAIGONBANK' healthy operation, high quality,

efficiency, publicity, transparency, and legal compliance.

- Supervising, directing, pushing the General Director to implement solutions to achieve the business plan targets set by the GMS and the operational plan outlined for 2025:

+ Solutions for growing the mobilized funds, optimizing cost of mobilized funds;

+ Solutions for a safe, efficient and compliant growth of credit, directing the flow of credit towards production and business sectors, priority areas, and economic growth drivers in accordance with the policies of the Government and the Prime Minister. In the course of 2025, SAIGONBANK launched 16 credit packages of preferential lending rates. Total preferential credit limit of 2025 reached above VND11.000 billion to support business and manufacturing development of the clients, to meet capital needs for daily life, to support the collective economic sector, cooperatives and social housing purchases, etc.; Directing the implementation of solutions to promote green credit growth and low-carbon production and consumption sectors to save the environment. By the end of December 2025, the outstanding green credit balance was VND 697,46 billion; Improving the efficiency of resource and energy use/saving contributes to the implementation of the banking action plan on green growth, gradually moving towards the image of a green bank, and applying ESG in operations.

+ Promoting, expanding, and improving the operational efficiency of branches and transaction offices (network); reorganizing the network.

+ Promoting the development of digital services and technology applications, implementing digital transformation in operations in accordance with the policies of the Government and the SBV.

+ Directing, monitoring the improvement and implementation of internal regulations and procedures of SAIGONBANK in certain operational respect for timely revision, supplement and new issuance ensuring the compliance with regulations and aiming to adopt advanced international practices and standards.

- Directing the development of a contingency plan for early intervention in case of necessity at SAIGONBANK, disclosing information and reporting to the SBV as stipulated in Article 143 of the Law on Credit Institutions.

- Directing the implementation of increasing charter capital through share issuance from accumulated undistributed profits at a rate of 6,5%.

- Directing the communication activities and enhancing SAIGONBANK's brand identification through community-oriented, social, and humanitarian sponsorship programs: coordinating with Ho Chi Minh City Television to successfully organize the 20<sup>th</sup> Chuong Vang Vong Co (Golden Bell of Traditional Music) Program; The People's Committee of Ho Chi Minh City awarded SAIGONBANK and three individuals in form of merit certificates, recognizing their persistent contributions to preserve and develop Cai Luong (Vietnamese traditional opera); offering gifts to the Association of the Blind and disadvantaged families in Tan Kien commune, Binh Chanh district, Ho Chi Minh City; Sponsoring Vietnam Salt Festival - Bac Lieu 2025; Donating electric vehicles to transport patients to Cho

Ray Hospital; Coordinating with Ho Chi Minh City Association for the Support of Poor Patients to organize a free eye surgery program to bring sight to poor patients in Bao Loc, Lam Dong province; Supporting people in provinces severely affected by storms and floods.

- Internal Audit Department (under the BOS) regularly conducted the remote monitoring toward the units, the implementation of the General Director's instructions from time to time and reported to the BOD, BOS, and BOM.

- During the BOD meetings, the General Director reported on SAIGONBANK's operational situation, the execution of the GMS resolutions, the BOD resolutions, the difficulties and obstacles encountered during implementation. Based on this, through evaluating business performance and analyzing market scenarios, the BOD made timely decisions and issued directives closely relevant to the practical situation.

- In 2025, the BOD and BOM proactively and timely issued the policies, action programs, proposed appropriate solutions focused on the business development, accelerated the handling progress and concentrated efforts to resolve hindrances faced by each branch within the entire system, thereby ensuring the achievement of business growth objectives.

#### **4. Activities of Committees under the BOD (if any):**

According to the regulations of the SBV, the BOD has established the committees as follows:

##### **4.1. Board Nomination Committee (BNC):**

The Board Nomination Committee (BNC) was established under Decision No.76/QĐ-HDQT dated April 28, 2010 of the BOD in accordance with the provisions of the law and has been improved several times to suit SAIGONBANK's actual operation from time to time. In 2025, the BNC performed its functions, tasks and achieved following results:

- Strategically advising the BOD on matters within the BOD's authority including developing human resource policy, selecting and appointing personnel to positions within the BOD's authority; defining regime on salary, remuneration, bonus for employees at SAIGONBANK; assisting the BOD in supervising the execution of regime, policy on human resources and other human resource management activities of SAIGONBANK;

- Consulting the BOD on handling personnel issues that have arisen during the process of electing, appointing, dismissing, removing officials in accordance with statutes, regulations;

- Overseeing SAIGONBANK's compliance with the provisions of the law on utilizing the human resources;

- Advising the BOD on applying Key Performance Indicators (KPI) to staff and officers in each belonging units to improve their accountability, efficiency and productivity.

- Proposing to send managerial officers, staff to training programs, symposiums to have their knowledge stay abreast of prevailing legal requirements and to improve their professions;

- Through the BNC's advisory work, the BOD has given timely attention and direction, thereby enhanced SAIGONBANK's qualified human resources, especially in developing an IT talent pool that possesses high level of specialty and professionalism to fulfill the personnel demand of banking industry within the current context of digital transformation.

- Regarding organizational structure, the BNC has advised, improved organizational model in the direction of streamlining, specializing and clearly defining functions, tasks, effectively enhancing cooperation among departments and business units.

#### **4.2. Board Risk Committee (BRC):**

The Board Risk Committee (BRC) was established under Decision No.77/QD-HDQT dated April 28, 2010, of the BOD in accordance with the provisions of the law and has been improved several times to suit SAIGONBANK's actual operation from time to time. By strictly sticking to SAIGONBANK's business plan for 2025 and operations, the BRC has performed its functions, tasks as follows:

- Strategically advising the BOD on issuing regulations and policies relating to risk management within the BOD's authority in accordance with the provisions of the law.

- Analyzing, issuing warnings about the potential risks that could possibly impact the safe business of SAIGONBANK and measures for preventing these risks in short term as well as long term.

- Reviewing, assessing the congruence and effectiveness of SAIGONBANK's risk management procedures and policies to make recommendations, proposals to the BOD on requirements for changes to current procedures, policies and strategies.

- Consulting the BOD for approving SAIGONBANK's investments, related transactions, governance policy and risk resolving plan within the scope of functions and tasks assigned to the BOD.

- Reviewing and deciding SAIGONBANK's significant risk portfolio, thereby developing active solutions in managing and mitigating risks. In particular, the management, recovery and handling bad debts, doubtful debts has been given top priority, which is appropriate with general policy of the Government and the SBV;

- Consulting the BOD on continually implementing Basel II standards to improve the effectiveness of operational risk management and proposing the required preparations to implement Basel III standards. In 2025, SAIGONBANK issued 18 new regulations, policies and procedures of risk management as well as amendments, supplements for a number of relating ones; Supervising the implementation of Circular No.41/2016/TT-NHNN dated December 30, 2016 (amended and supplemented) of the SBV prescribing prudential ratios for banking operations and Circular No.13/2018/TT-NHNN dated May 18, 2018 of the SBV prescribing internal control systems of commercial banks.

- Regularly observing the execution of SAIGONBANK's risk management policies; timely producing risk warnings and respective recommendations for SAIGONBANK's regulations, policies and services;

- Advising the BOD on supervising the implementation of critical risk limits.

- Advising the BOD on controlling the balanced capital position and liquidity, interest rate risk management to ensure safety, effectiveness and the compliance with regulatory limits for the Bank's operation.

- Advising the BOD on the execution of liquidity, market, operation and credit risk management in the entire system; Building, creating a governance structure that shall be systematic, consistent, effective and appropriate to the Bank's operation scale.

#### 3. BOS's oversight over the BOD, the BOM and Shareholders:

- The BOS has carried out their work of supervision over SAIGONBANK's governance and executive operations in respect of its compliance with the law and internal rules, charter, resolutions or decisions of the GMS and the BOD.
- The internal audit was organized and implemented to fulfill assigned tasks and execute the approved internal audit plan of SAIGONBANK. Through internal audit activities, on the one hand, the BOS monitored the compliance with legal and internal regulations of SAIGONBANK. On the other hand, the BOS evaluated the efficiency of critical business activities as well as figured out the possibility that SAIGONBANK's safe operation might be exposed to potential risks.
- Monitoring compliance with the regulations per Chapter VII of the Law on

Credit Institutions regarding restrictions to ensure SAIGONBANK's safe operations.

- Monitoring the financial situation and reviewing the semi-annual and annual financial reports of SAIGONBANK.

- Shareholders owning 1% or above of the charter capital, together with related members of the BOD, of the BOS, of the General Director of SAIGONBANK were listed; this list has been maintained and regularly updated upon changes. In 2025, there were changes in the ownership of shareholders holding 1% or above of SAIGONBANK's charter capital: Phat Dai Cat Joint Stock Company increased its ownership from 4,945% to 9,889%; Dai Phu Quy Consulting Joint Stock Company held 1,466%; Phat Dai Bao Joint Stock Company and Evergreen Capital One-Member Limited Liability Company were no longer shareholders of SAIGONBANK.

Other inspection and supervisory activities were conducted as prescribed by the law.

#### **4. Coordination between the BOS and the BOD and other managers:**

During the course of operation, the BOS received necessary information and documents regarding executive management, operation, and business activities of SAIGONBANK to well perform their job of inspection and supervision. The coordination is always based on the principle of SAIGONBANK's strict alignment with the regulations of SBV, internal rules and charter of SAIGONBANK.

Based on the results of high-level supervision of internal audit, the BOS made opinions and recommendations to the BOD and the BOM expecting an enhancement of the internal control system, risk mitigation, legal compliance either with the law or with the internal regulations. This contributed to improve the quality, efficiency, and safe operation of SAIGONBANK.

#### **5. Other activities of the BOS:**

- The BOS issued new internal regulations to comply with current regulations: The organization and operation statute of the BOS of SAIGONBANK; Internal Audit Statute and Internal Audit Procedures.

-The BOS carried out appointment and reappointment for positions in the Internal Audit Department and directed this department to submit reports as required by the SBV.

-The BOS members were assigned to directly join with the Internal Audit Department in inspecting activities at SAIGONBANK's branches.

-Reporting as per requirement of the competent authorities.

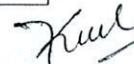
